5. Participants will learn documentation strategies for music therapy treatment plans that will help determine changes in service levels, including termination. (CBMT Scope of Practice II. A. 3., C. 1-4, III. A. 1-3, 5-7)

At exit #74, turn north onto U.S. 131, go 2.8 miles, follow the directions listed below for U.S. 131.

From U.S. 131

At exit #36A, turn east onto Stadium Drive, follow directions listed below for your destination.

To Miller Auditorium and parking ramp 2

Drive 2.2 miles to Howard Street; turn left and go 0.2 miles; turn right onto access road to Western Avenue. Turn right immediately onto Western Avenue. Go to stop sign and turn left. Proceed to parking ramp 2 (next to Miller Auditorium). Walk from the parking structure, past Richmond Center to Dalton Center (pictured below). Enter through the front doors and register in the lobby.
